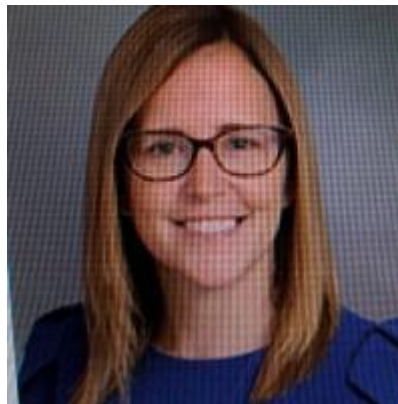

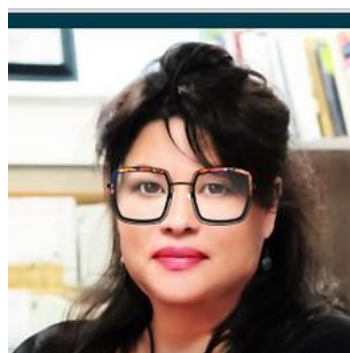

**Anjanette Young, LCSW**

Anjanette Young is committed to educating her community and others about the injustice she experienced at the hand of the City of Chicago Police Department. As a survivor of injustice, Anjanette understands and empathizes with those who decide to remain silent or who are discouraged from speaking about their experiences. However, she chose to share her experience despite the humiliation and pain it caused her.

Addressing racial injustice and inequity should be a top priority to all. My grandmother, Lucienda Young, was an Egalitarian. A Civil Rights Activist who marched with Rev. Dr. Martin Luther King Jr. Although I was not born when her activism started, my interest in Social Justice developed through hearing her stories of the Civil Rights Movement; and for that reason, it was necessary for me to stand in her shoes and fight for justice for myself and others in the city of Chicago who had similar experiences at the hand of the police. I am in that generation that experienced integration and the uphill battle all African Americans faced. I grew up in rural Mississippi where the challenge was incredibly difficult. However, I had no other path to take. Civil Rights, and Social Justice...is in my DNA. So, for me, the work of being a Social Worker was always and has always been about the work of trying to find ways to bolster tolerance in our society, to help people live together better, and adjust to changes and challenges in their lives.

As an accomplished Social Worker and Public Speaker, Anjanette Young is one of the leading experts in the Chicagoland area speaking truth to power, about issues related to Social Injustice, Mental Health, and the Social Work Profession. Anjanette has been the guest Lecturer at both Howard University and Monmouth University, Jane Addams School of Social Work as well as the Keynote Speaker at Anti-Racism Summits, Town Hall Events, and Podcasts, speaking on Social Justice and surviving trauma from a Social Work perspective.

Anjanette is already doing this through her company Café' Social Work Consulting, where she mentors, coaches, and tutor social work students and professionals. Anjanette also launched a support campaign "I AM HER", I AM HER encourages all women and young girls to speak truth to power about any issue that has brought them hurt or pain.

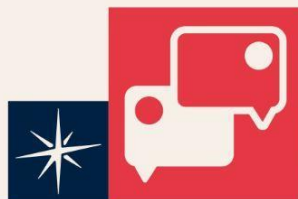

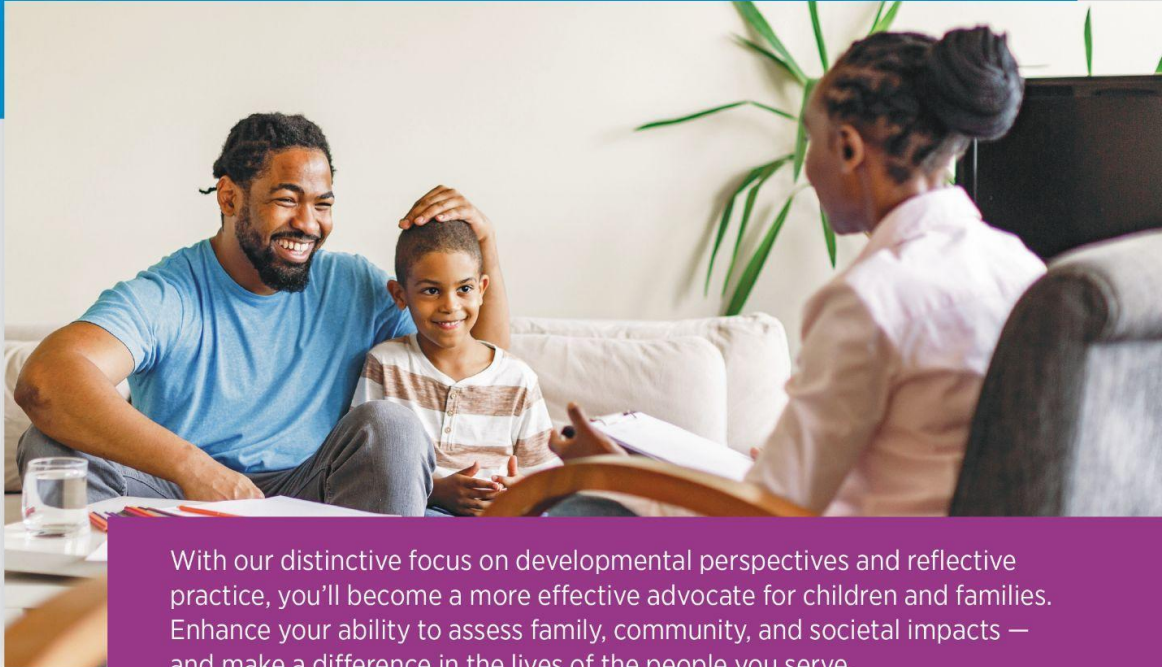
